This Agreement shall become effective on July 01, 2026 and remain in full force and effective through June 30, 2029. The 2026-2029 San Diego Cement Masons Master Labor Agreement provides for a **\$4.03 per hour increase effective July 01, 2026**. The Union has determined to allocate the increase as follows: Supplemental Dues \$0.10 increase, Defined Contribution (IRA) \$1.50 (**Newly negotiated benefit**) and to Wages \$2.40 increase. ***The allocation of \$0.03 will be added to SDCAF, per Association request.***

(*Future Allocations: July 01, 2027- \$4.75; July 01, 2028 \$4.75)
